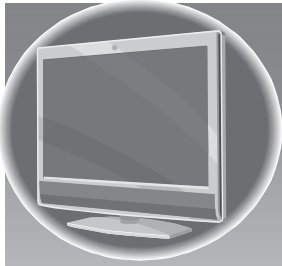


# Your Financial Friend



## Do you want a new TV?

E-statements are accessed from your personal account page at [www.amicus.coop](http://www.amicus.coop) and allows you to view up to 13 months of statement activity.

### Getting started with E- Statements

To sign up for E-Statements, log onto your account at [www.amicus.coop](http://www.amicus.coop)

- Click on the e-statements tab at the top of the page
- Click the circle to accept terms and conditions
- You will receive a verification e-mail when completed

- Click on statements

### To print your e-statements:

- \* Click on the PDF tab at the top of the page or
- \* Click on the printable version link on the page

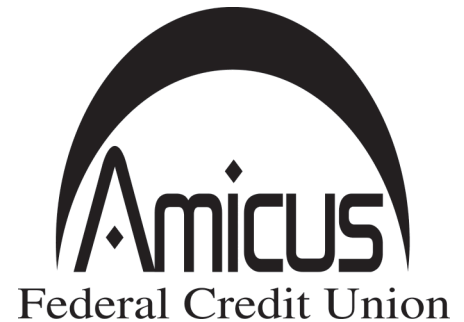
